Veterans Exemption

Did you know that the Office of the Assessor-Recorder applies exemptions to U.S. military disabled veterans? Last year the Office of the Assessor-Recorder granted approximately \$25 million in exemptions to 184 veterans with disabilities and their families. Qualifying veterans must have been disabled due to service-related injury or disease while in the armed forces and must be a resident of California beginning on January 1st. Veterans with 100% disability, partial disability, or unmarried surviving spouses are eligible for exemptions based on income. Proposition 19

Passed in November 2020, Proposition 19 repealed laws that governed intergenerational property transfers after February 16, 2021. The measure also allows homeowners 55 or older, or severely disabled to transfer their existing assessed value to a new home anywhere in the state. Tax Assistance

The California Property Tax Postponement program allows eligible homeowners (seniors and those who have a disability) to defer property taxes. Applications for this state program are available beginning October 1, 2023.

San Francisco Police Department (SFPD)'s Financial Crimes Unit is tasked with the investigation of financial crimes including but not limited to: embezzlement, false financial statements, forgery, identity theft, internet fraud, elder financial abuse, non-return of rental property, real estate, and notary fraud. Floodwater Management Grant Program

Receive a grant of up to \$100,000 to floodproof your property through SFPUC's Floodwater Grant. If you have experienced flooding entering your property through plumbing fixtures or the public right-of-way caused by heavy rain events and wish to apply for a Floodwater Grant to install flood protection modifications to your property, visit www.sfpuc.org/programs/grants/floodwater-management-grant-program and submit a detailed Grant Interest Form via email to floodwater.org.

Earthquake & Natural Disaster Readiness

Six Steps to Stay Safe. It's not about if, it's about when.

1. Make a Plan

Organizing family will be a top priority. Choose somewhere to meet and a person that is out of the area to relay messages.

2. Secure your Home

Secure loose objects, strap down heavy furniture, and shakeproof your home by retrofitting weak spots.

3. Get a Kit

Build a kit to get your family through at least three days. This includes access to cash, prescriptions, important documents, non-perishable food items, bottled water, among other potential items.

4. Drop, Cover, and Hold On

When the quake starts, drop down where you are, and cover your head. If you're close to heavy furniture, then take cover underneath and hold on.

5. Check Hazards

When the shaking stops, check for injuries and damages. Home electrical wires, gas lines, and water pipes should be examined.

6. Stay Connected

Surviving an earthquake is a community effort. Get to know your neighbors and work together with local organizations to prepare.
